REVISED EDITION OF BRITISH STANDARD 7533 PART 3

All British Standards are developed with a period of public inquiry and consultation utilising expertise from a wide range of areas, such as consumers, academics, special interest groups and business and industry including Interpave and Interlay. The standards produced represent a consensus on current best practice.

Unlike Building Regulations, British Standards are not mandatory but advisory documents; however, they are generally accepted as the preferred method of work. In the Interlay Code of Practice it is stated that work is undertaken in accordance with the relevant British Standards particularly BS 7533.

WHAT IT MEANS TO YOU.

It is important that members are familiar with the current edition of BS 7533.3 - Pavements Constructed with Clay, Natural Stone or Concrete Pavers - Part 3 "Code of Practice for Laying Pre Cast Concrete Paving Blocks and Clay Pavers for Flexible Pavements".

After a long consultation period this standard was revised and amended and came into effect on the 20th October 2005. We have reviewed this edition and written a document that explains the changes and additions over the previous edition. A PDF of this Review is available on the Interlay website in the Members Area.

We recommend that you purchase a copy of this BS 7533.3 from British Standards for your own use. This can be done via the British Standard web site <u>www.bsi-global.com/index.xalter</u> or on 0208 996 9000 at a cost of £92.00. (£46.00 for BSI members).

ALL CHANGE FOR PAVING STANDARDS

Revision of the Installation Code of Practice BS 7533 Part 3 is just one example of the changes going on with Standards for paving now and over the next few years. It is essential that Interlay members keep up to date and to help with this we are including a new 'Summary of Standards' on the Interlay website in the Members Area.

Here you will find a table summarising the nineteen British Standards that apply to precast concrete paving. Not only does this tell you what version is current but also schedules the standards to be written or amended.

You can provide input into writing and amending standards directly or via your representative on the Technical Committee, Mark Pointer of Tolly Paving

This important resource will be kept up-to-date, so do visit it from time to time.

Royal Horticultural Society – Permeable Paving Awareness

Special thanks this issue to Gary Cooper Paving who alerted us to an article in their local paper about an RHS produced leaflet. The article called "Paved with problems" was faxed through to us and we were able to get a response out to the editor in defence of block paving.

The article focused on potential problems that may occur with the overuse of paving in front gardens. Unfortunately, the article didn't mention that the Royal Horticultural Society **encourage** permeable paving as a solution to this problem. In this instance the letter was not published, but our comments were noted. However, as a result of the article, Interpave are in discussion with the Royal Horticultural Society to assist them in expanding the use of permeable paving in these applications.

Interpave are undertaking PR following up on the recent TV and Radio coverage of the Royal Horticultural Society's debate regarding paving and driveways in front gardens.
